Here is the Review Process we follow:

<p>Step #1: Owner reads the Restrictive Covenants (CCR’s) . This document is located on the Hat Island Website Document Library. <u>Your signature is required</u> on this form to confirm that this document has been read and you agree to adhere to all CCR’s as a condition of approval of your project.</p>	<p>Step #2: <i>Submit your completed/signed Building Submission Form along with your plans, detailed drawings including lot setbacks, and specifications to the HICA to the attention of the Island Manager.</i></p> <p><i><u>All Lots must be identified with corner markers and your building/project staked within your lot lines</u></i></p>
<p>Step #3: The ACC will review your documents for the project, make a site visit <u>and</u> review your submission for lot line setbacks, and check conformity with the Restrictive Covenants (CCR’s). If there are questions regarding the project the Committee will contact you for clarification.</p>	<p>Step #4: <i>The Island Manager will notify you of the approval or rejection of your proposed project. For new construction, a “Water Letter” will be provided (based on water-hookup availability). Contact the Island Manager for Water Letter information, availability, and costs.</i></p>
