Application for Digital Parking Permit Instructions

The Port of Everett and its partner LAZ Parking have streamlined the Parking Permit process using a digital permit. As such, you will not have a physical permit in your vehicle as the state license plate on your car will be read by our system and you are able to register multiple cars on one permit so long as only one car is parked using the permit at a time. For 2023, the Port / LAZ Parking is manually entering permits for Hat Island.

Once you provide the needed information with your payment, LAZ will process your application and, once authorized, you will receive an email confirming your permit is activated. This may take up to 48 business hours.

Hat Island parking is located within the general visitor parking areas of South Marina. A parking map is shown below showing the locations you may park once you have your email confirming the activation of the digital permit.

START BY COLLECTING THE INFORMATION REQUIRED in the application:

- **Make, license plate and state of registration for each vehicle** – you may register more than one vehicle per permit but only one can use the permit at a time.
- **Hat Island lot number and address used to confirm your eligibility for permit. Permits are available to those who own property or their dependents.**
- **Email address** -*Please note if you do not have an email, please indicate so and your confirmation will be mailed.*
- Primary address
- **A contact phone number** so we are able to reach you if there is an issue with your permit or vehicle. Please use one you would have access to when traveling as attempt to contact you if there is a serious problem.

Hat Island Monthly or Annual Permit Parking Location

These permits are valid in the South Marina Lot 8 shown on the figure below in blue highlight.

With this permit, you may park up to 29 days without moving your vehicle. On special event days, you are not required to pay the fee.

Please note: Do not park in the Marina Village 2-hour parking for greater than 2 hours, or in the Marina Slipholder reserved parking areas. All vehicles must be street legal and operational. Vehicles may not be covered.

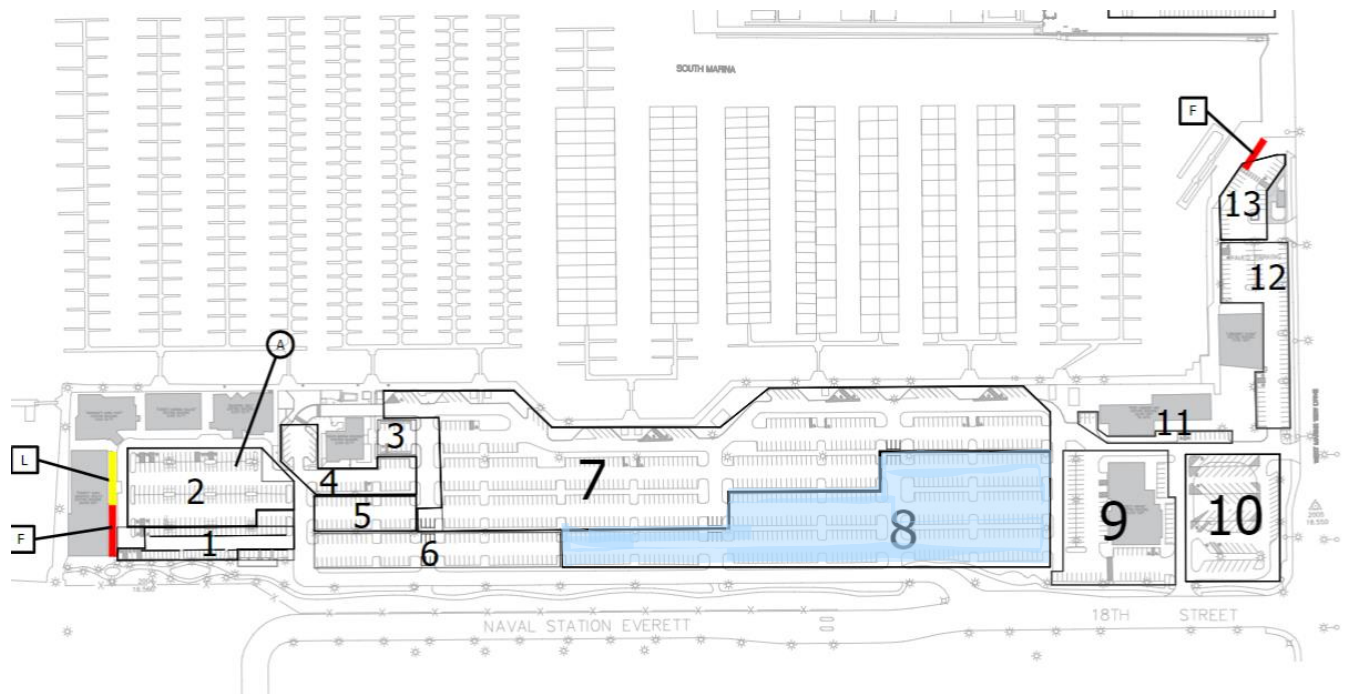


Figure 1 South Marina – Lot 8 In blue

Hat Island Monthly or Annual Permit Terms

The payments for parking are generally non-refundable, once paid you have agreed to to the term length associated with the parking. Annual Permits are good until December 31st of the year purchased and Monthly Permits are only good for the month purchased. For example, if a monthly permit is purchased on August 31st, the person has purchased a monthly permit and the term for that parking ends on September 30.

There will not be advanced purchasing of monthly parking in 2023. If you are purchasing monthly parking, you will need to activate it prior to the month you are parking and then deactivate it when you no longer are parking.

There are only 45 guaranteed parking spaces, these are reserved for Annual Permit holders only. While there may not ever be an overflow of Lot 8 (as indicated on the previous page) parking, the Port and Laz reserve the right to cancel Monthly Permits or stop adding Monthly Permits to account for demand on Lot 8 visitor parking. The Monthly Permits that have been open the longest will have priority in determining which Monthly Permits to cancel.
