**HAT ISLAND COMMUNITY – SLIP HOLDERS**  
**Long-Term Parking Permits – “Hat Island Endorsements”**

For 2023, the Port of Everett has elected to offer **annual** parking permits to Hat Island Owners who are also Slip holders (“Hat Island Slip holders”) **instead** of monthly parking permits. These permits are sold as an *enhancement* to your current Slip holder Parking privileges.

In 2022, this was previously called a “Liveaboard Endorsement” and available to be purchased by Hat Island Slip holders for \$35 per vehicle on a monthly basis. **These monthly Endorsements will be no longer available as of 2023. The last day for the monthly program is 12/31/2022. Current monthly Endorsement Permit holders will be terminated after that day and must fill out this form to enroll in the new annual program.**

The new Annual Endorsements will allow the same privileges as the 2022 Monthly Endorsements at a **lower rate**. Just like the 2022 Monthly Endorsements, the 2023 Annual Hat Island Endorsements will allow Hat Island Slip holders to park for up to 29 days, consecutively (without moving their vehicle off Port of Everett property) without having to sign up for long-term parking, or for use after their Slip holder long-term parking was gone.

Each Slip at the Port of Everett is granted an allotment of 29 days of long-term parking per calendar year. “Long-Term Parking” is defined as starting on the 5<sup>th</sup> day of parking without the vehicle being moved off the property. Once a Slip holder's Long-Term Parking is used up, parking is charged at the market rate of \$10 per day for every excess Long-Term Parking Day for each trip for the rest of the calendar year.

**The Hat Island Endorsement is only available to Hat Island Slip holders.** Only Hat Island Slip holders are being granted this opportunity. Hat Island Slip holders are the only non-liveaboard Slip holders who are offered the ability to use more than the allotted 29 days of Long-Term Parking per calendar year at this offered discounted rate.

**If you do not purchase an annual Hat Island Endorsement by January 31<sup>st</sup>, 2023, you forfeit the option to do so until the 2024 enrollment period. All long-term parking after your initial 29 days will be billed at the market rate of \$10 per day for the remainder of the calendar year. All valid citations received for failure to register for long-term parking, or overuse of long-term parking will be upheld.**

For 2023, the Port of Everett is instead offering two different **annual** passes: “Premium Hat Island Endorsement Permit” and “Stand-Alone Hat Island Endorsement Permit”.

**Premium Hat Island Endorsement Permit: \$400 annually**

- Register as many vehicles as you own.
- Park up to two vehicles simultaneously.
- No need to register for Long-Term Parking.
- Vehicles can remain parked in the appropriate lot(s) up to 29 days at a time without needing to be moved.
- Central and North Slipholders are permitted to park in their corresponding Slipholder Parking Basins, as well as the South Marina Slipholder Parking.
- South Marina Slipholders are permitted to park in the South Marina Slipholder Parking.
- Less than half the price of two of the 2022 monthly endorsements.
- Less than a quarter of the cost of a Liveaboard Endorsement.

**Stand-Alone Hat Island Endorsement Permit: \$210 annually**

- Register only **one** vehicle.
- No need to register for Long-Term Parking.
- Vehicles can remain parked in the appropriate lot(s) up to 29 days at a time without needing to be moved.
- Central and North Slipholders are permitted to park in their corresponding Slipholder Parking Basins, as well as the South Marina Slipholder Parking.
- South Marina Slipholders are permitted to park in the South Marina Slipholder Parking.
- More than half the price of one of the monthly 2022 endorsements.
- Less than a quarter of the cost of a Liveaboard Endorsement.

**If you cancel your Slip or sell your Hat Island property before the end of the year, you will forfeit your Hat Island Endorsement parking permit. There will be no refunds (partial or full) or transfers of permits. There will be no proration.** Purchase of an Annual Hat Island Endorsement Permit forfeits your long-term parking days since your permit will negate the need to register for long-term parking for 2023.

## **Application for Hat Island Endorsement Instructions**

The Port of Everett and its partner LAZ Parking have streamlined the Parking Permit process using a digital permit. As such, you will not have a physical permit in your vehicle as the state license plate on your car will be read by our system.

Once you provide the needed information with your payment, LAZ will process your application and once authorized, you will receive an email confirming your permit is activated. This may take up to 48 business hours.

**START BY COLLECTING THE INFORMATION REQUIRED** in the application:

- **Make, license plate number and state of registration for each vehicle**
- **Slip number (Ex. SLW023)**
- **Hat Island Lot number and address used to confirm your eligibility for endorsement.** *Endorsements are available to those who own property or their dependents who are also slipholders as verified by the Port of Everett.*
- **Email address**
- **Primary address**
- **A contact phone number** so we are able to reach you if there is an issue with your endorsement or vehicle. Please use one you would have access to when traveling as an attempt to contact you if there is a serious problem.
